2. WILLIAM² CASH (*WILLIAM*¹ *CAISHE*) was born 1653 in Strathmiglo, Fife, Scotland, and died August 1703 in Westmoreland County, Virginia. He married ELIZABETH SKINNER 1699 in Scotland, daughter of JOHN SKINNER and ELIZABETH. She was born 1655 in Staffoed County, Virginia, and died March 09, 1749/50 in Staffoed County, Virginia.

Notes for WILLIAM CASH:

WILLIAM CASH, the progenitor of the southern branch of the CASH Family, first appears in the records of Westmoreland County, Virginia, 30 May 1694, on which date he was sworn as a grand juror. It is clear from the evidence, however, on this date he owned a large landed estate, therefore probably arrived in that place some years before. It is believed he came to Virginia from England ca 1680, and is therefore referred to by most CASH researchers as "The Emigrant". His date of birth is estimated as ca 1660. His plantation was situated in Washington Parish, Westmoreland County, but when King George County was formed from part of Westmoreland in 1720, approximately half of this land fell into each county. His first wife is unknown, however he probably first married ca 1688. His first wife probably died ca 1698 and he was then married ca 1699 to Elizabeth, believed to have been the daughter of his friend and neighbor John SKINNER, a Quaker. He died in Westmoreland County, Virginia between 16 February 1708, the date of his Will, and 25 August 1708, the date of probate.

A British tax record in 1677 lists William Cash as "seated" in Washington Parish, Westmoreland Co. Va. He left a will, written 16 February 1708/7, and recorded in Westmoreland Co, 25 August 1708, naming his children: William, Thomas, John, James, Howard, Joseph, Peter, and a daughter, Anise Cash. His wife, Elizabeth was named as executrix and guardian of his children, William, Thomas, Anish, until they became of age. Therefore it is believed all the other children were older than these three whose ages were given in the will. Peter Skinner was named as executor, and John Skinner a witness.

WILL OF WILLIAM CASH, WESTMORELAND COUNTY, VIRGINIA. [Will Bk 4:141-142]

In the name of God Amen! I, WILLIAM CASH, being sick and weak of body but of perfect sense and memory praise be God, do make and ordain this my Last Will and Testament Revoking all other wills heretofore made save only this in manner and form followeth: I give my soul to God which gave it and my body to the Earth there to be decently buried according to the discretion of my executor in sure and certain hopes of Resurrection and that I shall see my Savior at the last day.

Item. I do make my loving wife ELIZABETH CASH my Executrix and PETER SKINNER my Executor. Item. I give unto my loving wife my plantation with a third part of my land during her life.

Item. I give one hundred acres of land being at the head of my land westward from my plantation to my son WILL: CASH and to him and his heirs and if he dieth without male heirs then tis my will that my son THOMAS CASH shall have it and his male heirs, and if my son THOMAS CASH dieth without male heirs

then it is my will that it should fall to my son JOHN CASH and to his male heirs.

Item. I give the remaining part of my land, it being one hundred twenty four acres to my son JAMES CASH and to his male heirs and if he die without male heirs, then it is my will that my son HOWARD CASH shall have it and if he dieth without male heirs, it is my will it should fall to my son JOSEPH CASH and his male heirs, and if he dieth without male heirs it is my will that my son PETER CASH and to him and his heirs forever.

Item. I give all my personal to my loving wife after my debts is paid. In witness whereof I have set my hand and seal this sixteenth day of Febr'y 1708/7.

To my son WILLIAM CASH underlined between the seventeen & eighteen lines before signed.

I having a fatherly care of my children do order them my son WILLIAM CASH to live dutifully with his mother until he be of age of one and twenty and likewise my son THOMAS CASH and my daughter ANIS CASH until she be eighteen years Of age and if she or either of them will not be governed by their mother then it is my desire that my friend and Executor PETER SKINNER shall have full power over them or either of them that will not be obedient unto their mother to take them to himself for the full time aforesaid. Notes for ROBERT HOWARD CASH:

We know his full name was Robert Howard Cash because of this deed filed by his son, Robert Howard Cash, after Howard's death. Abstract of the deed follows:

Deed Book E:38, Amherst Co. Va. 7 Sept. 1778. ROBERT HOWARD CASH and wife, TAMSEY, to HENDRICK ARNOLD, all of Amherst Co. for 150 lbs, 545 acres willed to the said ROBERT CASH by his father, ROBERT HOWARD CASH, deceased. Patented to ROBERT CASH 3 Nov. 1750 at Williamsburg.

WILL OF HOWARD CASH Amherst Co. Va. [Will Bk 1:228-231].

In the name of God Amen. I, HOWARD CASH, of the county of Amherst, being sick and weak of body, but of sound and perfect state of mind and memory and knowing that it is appointed for all men once to die, do make and ordain this my last Will and Testament.

First, I lend my wife, RUTH, eight negroes during her natural life, namely, Joseph, Cate, James, Charles, Sall, Dinah, Dick, and David.

Item. I lend to my beloved wife during her life the land and plantation whereon I live, which said land and negroes I lend to my wife during widowhood or natural life.

Item. I give to my son, JOEL, one hundred acres land joining the land on which he lives and 2 negroes named Dick, a boy, I give to my grandson, HOWARD, the son of JOEL CASH, after the death of my son, JOEL, to him and his heirs forever.

Item. I give to my daughter, MARY LIVELY, a negro wench named Sarah.

Item. I give to my son, BENJAMIN, 400 acres land adjacent to land that is at present the property of Capt. AARON HIGGINBOTHAM, and the land whereon I now live, also a negro fellow named James, whom I purchased of W. THOMAS MITCHELL.

Item. I lend to my daughter, ROSANNA, a negro wench named Fillis during her life and after her decease to my grandson, MICAJAH (her and her increase to him and his heirs forever).

Item. I lend to my daughter ANN POWELL, a negro wench named Peg during her life and after her decease to the heirs of her body and if she dies without issue my will is that the said negro her increase may descend to the children of my daughter, ROSANNA.

Item. I give to my son, ROBERT, 240 acres land lying between the land whereon I live and STEPHEN CASH'S land, moreover, I give to my son, ROBERT, 400 acres land which I left to my wife, after her decease, a negro boy named John and also a bed and furniture and 2 cows.

Item. I give to my daughter, MARY ANN, a negro boy named Ralph and also a bed and furniture and a cow and a calf.

Item. My will and desire is that my daughter, ELIZABETH NUCKLES, may have 30 pounds to be raised out of my estate which I have willed to my wife, to be paid in ten years by an order for 3 pounds a year upon some merchant as soon as it becomes due. I give to my daughter, RUTH, a negro girl named Nell and her increase to her and her heirs for ever and also a bed and furniture and a cow and a calf.

Item. I give to my son, STEPHEN, 5 shillings and I give to my daughter SARAH MAUZE, 5 shillings.

Item. My will after the decease of my wife, RUTH, is that two negroes, James and Charles, may descend to my son, JOEL, and Joseph and Cate to my son, BENJAMIN, and two negroes, Sall and Davie, to my son, ROBERT.

Item. My will is that after the decease of myself and my wife, the increase of Sall if any may be equally divided between my daughters, MARY ANN and RUTH, and if either of said daughters should depart this life unmarried or before they arrive to lawful age, the survivor of them should possess the issue of the negro woman.

Item. The residue of my estate which I have not already devised may go to my beloved wife during her life and after her decease to be equally divided between my three sons, JOEL, BENJAMIN, and ROBERT.

Item. I do not desire that my estate be appraised and I appoint my beloved wife, executrix, and my sons, JOEL, BENJAMIN, and ROBERT, executors of this last Will and Testament.

ADMINISTRATION OF RUTH CASH [Amherst Co. Va. Order Bk 1782-84:205-206] On the motion of HENDRICK ARNOLD, Adm. of the estate of RUTH CASH, Dec'd is granted him, who with CALEB HIGGINBOTHAM, his Security entered into and acknowledged their bond in the penalty of One Thousand Pounds, took the Oath required by law and ordered to be recorded.

5. JOSEPH³ CASH (*WILLIAM*², *WILLIAM*¹ CAISHE) was born 1682 in Westmoreland County, Virginia, and died July 23, 1799 in Granville County, North Carolina. He married (1) SUSANNAH MASON 1727. She died 1749. He married (2) ELIZABETH BRYANT 1750. She was born 1730 in King George County, Virginia, and died Bef. 1784.

Notes for JOSEPH CASH:

Son of William and Elizabeth CASH, was born in Westmoreland County, Virginia, Washington Parish, ca 1706. He was married ca 1727 to Susannah MASON, daughter of George and Ann MASON of Prince William County, Virginia and Dunham Parish, Charles City, Maryland. He owned a plantation in Brunswick Parish, King George County until 1733, at which time he was deeded 150 acres on the lower side of Dogue Creek, Turo Parish, Prince William County, by George and Ann MASON "for the natural lives of Joseph CASH, Susannah, his wife, and Ann, their daughter." This part of Prince William County became part of Fairfax County in 1742, and its present location is directly alongside of old U.S. Highway 1 (Post Road) south of Alexandria near a village then called Occoquan. Over the years he purchased several hundred acres adjoining this property and by 1752 owned at least 959 acres. Susannah MASON CASH died ca 1749 and he was married ca 1750 to Elizabeth, believed to be a member of the CULVERHOUSE family. In 1772 he was commissioned to survey Dogue Creek Road, which indicates he had a knowledge of surveying. In 1774 he and most of his family, together with the Hall and CULVERHOUSE families, moved to Dutch District (later Dutchville), Granville County, North Carolina, where he, his son Joseph, Jr., and grandson, Joseph Cash HALL, were granted approximately 1000 acres along Picture Branch Creek. He died in Granville County between 23 July 1779, the date of his Will, and August 1780, the date of probate.

NOTE: It might appear to some that there should be two men names Joseph CASH, father and son, instead of only one, since if only one man sired all these children he would have been about 68 at the birth of his last child, Elizabeth. Despite this, the evidence is clear that there was only one. When George MASON deeded the land to Joseph CASH in 1733 he named as the wife Susannah and daughter Ann. In his Will of 1779, Joseph referred to Ann as "my daughter Ann HALL." When Joseph's land was surveyed in 1779, Joseph Cash HALL was named as chain carrier on the survey party and Joseph Cash HALL was also granted land on the same date as Joseph CASH, Sr. and Jr., indicating he was over 21 at that time. In every case, his signature on legal documents was Joseph Cash HALL, clearly establishing his relationship to Joseph CASH Sr. Ann Cash Hall named a daughter Susannah, establishing in all probability that her mother's name was Susannah and Joseph Cash HALL named his eldest daughter Ann, named probably for his mother, Ann Cash HALL. In the 1786 North Carolina State Census, Joseph Cash HALL is shown to have 5 sons and 3 daughters, further establishing his likely birth date as ca 1752. In their Revolutionary War Pension Applications, both Peter and James, the sons of Joseph Sr.,, gave as their place of birth Fairfax County, Virginia, and that they moved from there to Granville County, North Carolina in 1774, further supporting the evidence that the Joseph married to Susannah in Fairfax County, Va., and the Joseph married to Elizabeth in Granville County, North Carolina, were the same man.

In the name of God, Amen. I, STEPHEN CASH, being weak in body through infirmity of old age, but of sound memory, do constitute and appoint this my last Will and Testament.

In the first place, I desire all my just debts to be paid by sons, WILLIAM CASH and JAMES CASH, to whom I give and bequeath my land whereon I now live, containing 295 acres, more or less, to be divided between my said sons, WILLIAM and JAMES CASH, by a line of division agreed on by them already. I also desire that my dear and loving wife may continue in peaceable possession of so much of my property as she may think proper to answer her necessities and the rest of my personal property to be sold and equally divided among the rest of my children not herein mentioned. And such property as my wife may see cause to keep during her life, at her decease, I desire that it may be divided equally as the rest of my personal property above mentioned.

Dekalb Co. Ga. 5 Nov. 1832. Personally appeared before Justices of sd county, PETER CASH, a resident of DeKalb Co., age 73 yrs on 21 Feb. last, and sworn, doth on his oath make the following declaration in order to obtain the benefits of the Act of Congress passed 7 June 1832. Deponent was on 4 tours during the Revolution in the militia of Virginia. Deponent chose the second division in order to accompany his older brother, JOHN CASH, and was drafted to the Barracks at Charlottesville, Albemarle Co. Va., serving 1 month under Capt. John Christian, Lt. Benjamin Toliver, Ensign (not recollected), & Kroger Shackelford, orderly Sgt. He was enrolled at age 18 in the month of Apr. in the first draft for barracks service. He served the second tour in the fall of the same year under Charles Christian, brother of his first captain. Part of the second tour his brother, JOHN CASH, served for him as a substitute, deponent being sick. Col. Taylor was the commander. No written discharges were given.

The Albemarle Co. and Amherst Co. militia had charge of the Barracks where were confined the prisoners of Burgoyne's defeated army who were afterwards removed to Winchester, Va. Again deponent served under the same division (they were counted as minutemen) under Samuel Higginbotham, Capt; Lt. James Ware, Joseph Staples, ensign; privates: James Gutland (nicknamed the Coon); HOWARD CASH, JOHN CASH, deponents brothers; John Giles, William Giles & Josiah Giles (3 brothers); William Venison; William Tyra; Dick McCary; and others.

Deponent served in the upper battalion of Amherst. This company marched through Albemarle, Fluvanna, and Goochland Counties to Richmond, Va. and took charge of the artillery. Capt. John Barnett's Co. from the lower battalion of Amherst accompanied Higginbotham to Richmond and from there marched to Petersburg. Higginbotham's company remained at Richmond until the end of the monthly tour and were discharged until called again into service under Capt. Pamplin, marched to Jamestown, having first joined the main army under Gen. Lawson at the Ground Squirrel Bridge, was in hearing of the firing at Battle of Jamestown and next night after the Battle marched by moonshine to the Battleground were fired upon & retreated past Hickory Mill Church where wounded men were receiving aid.

From thence to Mobbin Hill to Richmond to Newcastle upon Pamunkee River & there met Col. Samuel Cabell then lately exchanged from British confinement. Before they got to Jamestown the army prepared for Battle of Big Springs. McNess the officer, an Ensign, another officer who commanded the section to which he and his brother, JOHN CASH, belonged, slipped off home to Amherst which gave the field on which the parade was, the name of McNeeses field. About this time Gen. Lawson from some misconduct was deprived of his sword and command given to Gen. Stevens. There was a suspicion against Lawson that he held back from the battle. He did lie by during the day and marched the whole night in confusion.

From Newcastle deponent was marched toward York. A relief from Amherst overtook them at the Prickly Pair old field where he was discharged with others on 14 Aug. immediately preceding the capture of Cornwallis in Oct. Deponent received a written discharge which is lost. He was 3 months in this service. Deponent was taken sick at Mobbins Hill and was kept out of the hospital by JOHN CASH performing his camp duties. Deponent remained sick until after Wallace was taken viz until Christmas, Dr. John Rose attending.

Deponent was raised in Amherst. Some of his neighbors were Hugh Challis, Peter and John Rose, Charles and John Tolliver. Lived in Amherst until called out against the insurgents-or ... ?...- of Pa. under Dan'l Tucker, Capt; John Tolliver, Ensign; Henry Ballenger, Lt. Wm. Toliver, orderly Sgt; Gen. Matthews, highest commander. Served 3 months (lacking 9 days) and was dismissed. Deponent lived in Rockbridge Co. Va. with Joseph Alexander 1 yr, with the,widow McDowell, mother of Col. James McDowell now living near Fairfield- 1 yr then in Amherst near the Roses, Tollivers, Crawfords, & Cabells untilAprill827 & then moved to Georgia & his neighbors are John Hays, Thomas Johnston, Jesse Wallace, and Gerrard Ezzard of Decatur. s/Peter Cash.

Henry Co. Ga. 2 Nov. 1832. Personally came JOHN CASH, mentioned in the above declaration above as a witness to the facts, duly sworn, saith he was present with his brother, PETER CASH, in every tour mentioned, except that which Peter served under Capt. John & Charles Christian & also the service rendered against the insurgents of Pa., and all the statements made in sd declaration are true. He refers to the declaration made by himself to which reference may be made.

Affidavit given by John Hays, DeKalb Co. Ga., saying

Peter Cash is known as a Rev. soldier in the neighborhood. The court made note that Peter Cash was a Rev. soldier and served as he stated. However, the claim was rejected for lack of proof of six months service in person.

He enlisted to go out on the Cherokee Expedition on Holston River about the long Islands. He enlisted for during the expedition and was in service for 3 months, from September until just before Christmas. He enlisted in Amherst Co. Va. by Capt. John Sayle, Lt. James Franklin, Ensign Jesse Allen, and he thinks William & Nicholas Jones were sergeants.

This company formed what was called a ranging or scouting party-there were no higher officers . A small skirmish took place at Fort Chissell. The Indian towns were destroyed and the country generally had been saved from the Indians by previous larger forces consequently the company returned home to Amherst Co. where this deponent was born and raised and lived for 6 yrs after the close of the Revolution, and then moved into Bedford Co. Va. in the vicinity of the Rev. James Turner, lived there 13 yrs, and moved to Elbert Co. Ga. from there to here.

He marched with the company by the Big Lick, Botecourt, Va., English Ferry on New River, Fort Chissell & thence in various directions through the country. During this last winter of 1832 his house was consumed by fire, consuming his discharge from Capt. Sayle and a copy of an oath he made to save the country as also required.

His brother, PETER CASH of DeKalb County is acquainted with the circumstances of his enlistment, absence and return & who was a witness to other services rendered, as he will testify. Also, BARTLY CASH, one of sd company living yet in Amherst Co. Va., HOWARD CASH of Habersham, Ga., JOSEPH BOND, residence unknown, WILLIAM TYRY, JOHN SMITH, JAMES WARE, Dec'd, EDMUND HODGES, DAVID BELLOO.

Deponent was on 3 tours in the Virginia Militia. The militia was divided into numbers of ten and they were permitted to choose their numbers or were drafted. Deponent and his brother PETER CASH (who was present when this statement was made) chose number two and went into the militia service at the Barracks near Charlottesville in Albemarle & served 1 month Under Capt. James Pamplin. Col. Taylor was in command of the Garrison. No written discharges were given.

Albemarle and Amherst counties had charge of the Barracks where were confined the prisoners of Burgoyne's defeated army who were afterwards removed to Winchester, Va. Again, deponent served in the second division, counted as minuteman, under Capt. Samuel Higginbotham, Lt. James Ware, Ensign Joseph Staples. This company marched through Albemarle, Fluvanna, & Goochland Counties to Richmond, Va. and took charge of the artillery. Capt. John Barnett's company marched with Higginbotham to Richmond from there to Petersburg.

His company remained at Richmond until the end of the monthly tour & were dismissed by company until called again into service under Capt. Pamplin, marched to Jamestown, having first joined the main army under Gen. Lawson at the Ground Squirrel Bridge, was in hearing of the firing at the Battle of Jamestown. Next night after the battle, we marched by moonshine to the Battleground, were fired upon & retreated past Hickory Mill Church where wounded persons were receiving aid, from thence to Mobbin Hill, from thence to Richmond to New Castle upon Pamunkee River & there met Capt. Samuel Cabell, then lately exchanged from British confinement. About this time, Gen. Lawson, for some misconduct, was deprived of his sword and the command was given to Gen. Stevens. From New Castle deponent was marched towards York. A relief from Amherst overtook them at the Prickly Pair old field where he was discharged with others on 14th Aug. immediately preceding the capture of Cornwallis in Oct.

Deponent received a written discharge which was burned up 4 Dec. 1831 when deponent lost nearly all his property. Deponent was on a trip after salt to Fredericksburg when an...... came for his decision to go to York, by which absence he missed being present at the taking of Cornwallis.

Deponent is known by the Rev. James Gamble, John Lamar, Doctors Jacob Stokes & Francis E. Morrison. He hereby relinquishes any claim whatsoever to a pension except the present and declares that his name is not on the pension roll of any state ... further that nothing but old age & necessity arising from infirmity of himself & a helpless female family induces him now to call upon the generosity of his country. s/John Cash

Henry Co. Ga. 2 Nov. 1832. Personally appears PETER CASH who swears that he was present with his brother, JOHN CASH, in every service mentioned (Cherokee excepted), therefore making his said statement his own (being present), and swears that it is true in every particular as to the service, & believes it to be true

throughout. A full or similar statement ... by reference to a Declaration of deponent himself for his own

right which he will present to this Department.

LUCY CASH, WIDOW OF JOHN CASH, PENSION CLAIM

Has a number, may be 9087? (unclear). Georgia. LUCY CASH, Dec'd, widow of JOHN, a Private in the Revolution. Inscribed on the roll at \$26.66/yr, to begin 4 Mar. 1843, and ending 23 Jan. 1848. Certificate of pension issued 22 Mar. 1852 and sent to ANDREW R. MOORE, Griffin, Ga. Acts of 3 Mar. 1843 & 17 June 1844. Rec. Bk A, Vol. 2,p.42. In order to obtain the benefit of the Act of Congress 7 July 1838 entitled Act granting half pay and pension to certain widows.

Pike Co. Ga. 15 Mar. 1845. Personally appears before a Justice of the Inferior Court of sd county, LUCY CASH, a resident of Pike Co. Ga., aged 84 yrs, who being duly sworn makes the following declaration. She is the widow of JOHN CASH who was a Private in the Revolutionary War, having in his life obtained a pension under the Act of 7 June 1832, his services set forth in his Declaration on file in the War Dept. she presumes.

She further says she believes from information received from ANDREW R. MOORE of Henry Co. Ga. that the pension certificate of John Cash was forwarded to the pension office at Savanna (sic) at or about the time of his last application for a pension which he received in the month of Feb. 1836 and died 13,Aug. next thereafter. She married John Cash, 23 Jan. 1782. She was born 3 Mar. 1760 and John, as well as she remembers, was born 26 Apr. the year she cannot recollect but understood he lacked from the 3 Mar. to the 26 Apr. of being 3 yrs older than herself. She declares that a Bible which contained the dates of her and John's birth and marriage was burned with their-dwelling house in Dec. 1831.

She was married, after publication of banns, at the house of Charles Rose by a traveling minister, believes there was no license produced or read in the ceremony. Her marriage took place in Amherst Co. & she believes there is no record of her marriage. She & John lived 7 yrs in Amherst Co., 13 yrs in Bedford Co., moved to Elbert Co. Ga. about the year 1802 and lived there until 1829, then moved to Henry Co. Ga. and lived there until 13 Aug. 1836 at which date John Cash died. She declares that she was not married to him prior to his leaving the service. But the marriage took place previous to 1 Jan. 1794 viz at the time stated above. She is unable to appear in Court by reason of infirmity.

Ga., deceased, who was a Revolutionary soldier was the brother of deponent and was about 4 yrs older than deponent & he deponent will be 85 yrs of age if he lives to see the 14th day of Feb. next.

Deponent's father and his family resided at the time of the Revolutionary War in Amherst Co. Va. Deponent was not present when his brother John Cash deceased was married, but has the best of reasons to believe that he was lawfully married as he resided in the neighborhood at the time and heard he was married on a certain day and that there was an...... at his father's house on the next day & from that time until the day of his death he & his wife lived together as man and wife and raised a family of sons & daughters.

The reason why deponent was not at the wedding himself is that he was sick at the time and unable to go. The name of John Cash's wife prior to her marriage was LUCY CAMPBELL, and a short time after deponent heard of their marriage he went to his brother John's house & saw him & Lucy living together as husband and wife, and as to the date of marriage deponent thinkss that it took place previous to the year 1794 for following reasons. Deponent was married himself 1781 which was the summer before Lord Cornwallis was taken & his brother John was married in the winter after the surrender of Cornwallis to wit in the winter of 1782. He knows that John was married previous to the birth of deponent's oldest child, & by reference to the family record in which deponent registered the ages of his children he sees that his oldest child which was a daughter by the name of EFFEY was born on 3 May 1783. s/William (x) Cash

DeKalb Co. Ga. 18 Jan. 1848. Personally came before me, John Flowers, acting J.P., WILLIAM EZZARD, who after being sworn, saith that he is well acquainted with WILLIAM CASH who has made the foregoing affidavit & has known him to be a man of good moral character & unimpeachable veracity. Pike Co. Ga. 9 June 1851. Before me, Jason Burr, J.P., personally came NANCY and MARY CASH, who after being sworn, say that as well as they remember, their father, JOHN CASH, died in Aug. 1836 or 1837. Their mother, the widow of John Cash, died on the thirtieth day Jan. 1848. That they two and JAMES CASH of Campbell Co. Ga. are all the children of said John and Lucy Cash whom they know now to be

living. STEPHEN CASH resided in Mississippi 2 yrs ago. In that time they have not heard from him and therefore do not know whether he is living or not. All of them are much over 21 yrs of age. The youngest, MARY CASH, is 50 yrs old.

The last page of this record, sent by the National Archives to the compiler, is typewritten with some information filled in by hand, evidently a reply to someone's request for information. It is signed, Commissioner. The page says Lucy Cash died 23 Jan. 1848, and children of John and Lucy Cash were: James, b. 6 Nov. 1784; Nancy, 61 yrs old & Mary Cash, 52 yrs old in 1853, and Jane who died 14 Aug. 1848, and Stephen. Brothers (of John, it is assumed the writer meant), Peter, William, and James. It is not stated on the page as to where the writer got his information, and this page is not part of the original record. Published works tell the compiler a pension claim was filed also on 16 Mar. 1853, but those papers were not received by the compiler from National Archives. All papers are not sent in a file unless specifically requested. A son, George, died 14 Aug. 1848, is given on the 1853 claim, according to published works.

Notes for WILLIAM BICKNALL:

BECKNELL, WILLIAM (1787/88-1856). William Becknell, known as the "Father of the Santa Fe Trade," son of Micajah and Pheby (Landrum) Becknell, was born in Amherst County, Virginia, in 1787 or 1788. He married Jane Trusler there in 1807 and was living near St. Louis, Missouri, by 1810. He saw extensive service on the frontier during the War of 1812. He joined Daniel Morgan Boone's company of United States Mounted Rangers as first sergeant in May 1813. He was promoted to the rank of ensign in July 1814, shortly after Boone's nephew, James Callaway, assumed command of the company. Becknell participated in Maj. Zachary Taylor'sqv campaign against British-backed Indians that culminated in the battle of Credit Island, at the site of present-day Davenport, Iowa, in September 1814. He commanded the defense of Fort Clemson, Missouri, when Captain Callaway was killed by Indians in March 1815.

Becknell moved to central Missouri after the war and engaged in ferrying, freighting, and the salt trade. By 1817, after the death of his first wife, he had married Mary Cribbs, a Methodist from Pennsylvania, and had moved to Franklin, Missouri. William and Mary had three children. Becknell was an unsuccessful candidate for the Missouri House of Representatives in 1820. Motivated by financial problems, he organized a trading party that crossed the Great Plains to New Mexico in 1821. His party was welcomed to the previously forbidden province, and he returned to Franklin with encouraging profits. He took the first wagons across the trail in 1822 on his second journey to New Mexico, and led a party of trappers into Colorado on his third visit in 1824-25. He participated in the federal grading and marking project of the Santa Fe Trailqv in 1825 and 1826. He was appointed justice of the peace of Saline County, Missouri, in 1827, and was elected to the Missouri House of Representatives in 1828 and 1830 as a Jacksonian Democrat. He commanded a company of militia during the Black Hawk War.

In 1835 Becknell moved to Red River County, Texas. He mustered a company of mounted volunteers known as the Red River Blues in July 1836. The unit served along the Lavaca River until October. In that month Becknell reported to the capital of the Republic of Texas,qv believing that he had been elected to the House of Representatives, but relinquished his place when Collin McKinneyqv arrived from Red River County with a greater number of votes. Becknell subsequently commanded Red River militia companies in 1838, 1841, and 1842. Though he entered regional folklore as the foolish farmer who traded 1,000 acres of fertile land for a supply of antifever pills, he amassed a sizable estate in land and livestock in Red River and Lamar counties. He also owned a bridge spanning the Sulphur River. He was appointed to supervise the Texas congressional elections of 1845, and the United States congressional elections of 1846. Becknell died on April 25, 1856, and was buried near Clarksville.

The following is an account of the death of John W. Richards as printed in the Jan 22, 1920 edition of the Daily Sun.

John W. Richards, aged near forty years, and a member of a well known family of the Emhouse community, hung himself yesterday afternoon in his barn, using a rope suspended from a rafter in the barn. He was home at dinner and left the house some time in the noon hour, and when his children came home from school, they found hid dead body, which was still warm, hanging in the barn. A physician was summoned but life was already extinct.

The deceased is survived by his wife and three children, his parents, Mr. and Mrs. W.N. Richards and several brothers and sisters. He left nothing to explain his rash act.
