2. We have checked the sources listed on the second page and have been unable to find the information you requested.

5. The library search room is open Mondays 9:00-5:00, T-F, 8:00-5:00, and on Saturdays 8:00-1:00. The library is closed on state holidays.
6. Other: We have located the Confederate military service records for two men named McAfee who were members of the 11th Cavalry. One is Hugh McAfee and the other Hilliard McAfee. The reason we cite both is because it appears the records of the two may have been mixed and there is not definitive way to identify which records may belong to the man you seek. Records in their files are marked to H., H.H, H.M, and H.W. This is likely attributed to a misreading of the handwriting of the original documents. Since only initials were used in the record, the compiler made a best guess at to which file to place the records. No Confederate pension application or Confederate grave registration was found for Hugh McAfee. Because the records located number only a few pages, we are sending the copies gratis.
